

PAHA Recreational Rider Program

This program is for PAHA members and is designed to provide incentive awards for those hours spent riding or driving your horse noncompetitively. This includes hours spent trail riding, training and taking lessons. Hours spent cleaning stalls, grooming, doing groundwork or participating in competitions of any kind do not count.

Eligible Riders enroll in the program and designate one or more horses that will be used for accumulation of hours. Horses may be added or changed at any time, but all horses must meet the eligibility requirements.

Hours are self-reported and will accumulate from year to year in which the Rider remains current in the program. Level awards will be presented in the first quarter of each year for the previous year's achievements.

Start Date: January 1, 2014

Initial Enrollment Fee: \$20/rider

Yearly Fee: \$ 5/rider (due after the 1st year)

Eligibility and Rules:

- 1) Any member of PAHA in good standing (full, local or youth) may enroll in the program
- 2) To continue to accumulate hours the member must maintain membership in PAHA and have paid the correct fee(s). Hours ridden during a lapse in membership will not be counted.
- 3) Horses used to accumulate ride hours must be a registered Arabian, Half Arabian or Anglo Arabian. Registration numbers will be checked.
- 4) Horses do not need to be owned by the rider. More than one rider may accumulate hours on a single horse. Conversely a single rider may accumulate hours on multiple horses.
- 5) Riders enroll by filling out and submitting the PAHA Recreational Rider Program Enrollment Form and submitting it with the initial enrollment fee. An email will be sent to acknowledge successful enrollment and will be followed by a Welcome Letter showing the rider and the horse(s) names.
- 6) Riders may begin accumulating hours as of date of their Welcome Letter.
- 7) The period of enrollment will always end on December 31 of a year and begin on January 1 of the following year no matter when the initial enrollment was submitted. However, anyone enrolling in the last quarter of the year will not be subject to the yearly fee for their first year of participation.
- 8) Hours must be reported using the Hour Reporting Form. Forms may be submitted as often as desired. Any hours submitted after December 14 will be counted toward the next award year.
- 9) If the yearly fee is not paid for a period of more than 2 years, the accumulated hours will expire.
- 10) Renewal notices will be sent in November of each year. Renewal fees must be paid by January 1 or the enrollment will be suspended. Hours accumulated while under suspension are not eligible to be submitted until the fee owing is paid in full.
- 11) The Award Levels will be the following hour amounts:
50, 100, 250, 500, 1000, 1500, 2000, 2500, 3500, 4500, 6000
- 12) Hours used for this program can also be used toward any other program where ride hours are accumulated for awards/prizes.

Prizes for each level will include such items as caps, pins, mugs, totes, shirts and/or boxes.
