# **INFORMATION AND RULES**

**Ranch Clinic** We will be hosting a Ranch Clinic with Karlan Downing the day before our show on May 15 (Time TBA). This is open to exhibitors and PAHA members. The clinic is free to PAHA members. Non PAHA members we ask for a \$10 grounds fee. This is a great way to ask questions about Ranch and learn about the new classes offered. Lunch will be available to purchase from the Friendly Horseman's Club. **ALL CLINIC PARTICIPANTS MUST FILL OUT AN ENTRY BLANK AND SIGN RELEASE FORM! PLEASE WRITE CLINIC IN THE CLASS SECTION.**

**Add/scratches** Additional classes may be added without penalty except western dressage rides. Entries must be made 5 classes ahead. Even exchanges for post entries and scratches will be allowed provided they are done at the same time except western dressage rides. Entry fees will not be returned for scratched classes.

**Awards** Regular classes—six ribbons.

**Western Dressage Tests** Current WDAA Western Dressage Tests will be used.

**Western Dressage Rides** Rides will be limited to 30 rides on a first come first serve basis by postmarked date. A wait list will be maintained.

**Food** There will be food available to purchase from the Friendly Horseman's Riding Club on grounds both Saturday(Clinic) and Sunday(Show).

**Stabling** There is no stabling on grounds. There is limited stabling at Stony Run Fields located 4.3miles from show grounds, contact Laura at 717.371.3654.

**Calls for Classes/Tack Holds** The PA system is to be considered a courtesy only. Tack holds will be honored for back to back classes only. The office must be notified before the session begins.

**Entries** Entries must be submitted on the official entry form for this show; photocopies are accepted; both Sides of entry form required. Please type or print legibly. Additional forms can be requested from the show secretary or downloaded from paha.org. Copies of Registration papers and current AHA competition cards or single event membership fee for owners, trainers and riders must be presented at time of entries.

Note: AHA Membership/Competition card is not required for a parent or guardian signing the entry form for minors. Make all checks payable to PAHA-SC. Close of entry is May 3, 2021. Entries postmarked after May 3, 2021 are considered a post entry and will be charged a fee of \$15 per horse.

**Horse Health Requirements** All horses must present a current negative Coggins dated within 12 months of the show. **Out of state horses need a CVI dated within 30 days of the show per PA rules.**

**LIABILITY:** You assume the risk of equine activities pursuant to Pennsylvania Law.

**INDEMNITY AND RESPONSIBILITY** All entries are accepted with the understanding that neither PAHA, AHA, WDAA, the Friendly Horseman's Club- Grounds, the Show, the Show Committee, nor any Show Official will be held responsible for any loss, damage, or injury to any horse exhibited or any article of any kind. All horses shall be under the control and direction of the Show Committee but solely at the risk of the exhibitor, who will be responsible for any loss, damage or injury to any person, animal or property occasioned by him, and the exhibitor shall indemnify the above mentioned parties against any and all loss, damages and liability thus occasioned, including, but not limited to, any and all legal costs, including attorney fees, which may be incurred as a result thereof. Submitting of any entry form to the Show shall constitute an acceptance by each person signing same of the provisions herein set forth.

**All Breed Classes** are open to all horses and riders regardless of breed. No membership or AHA fees required. AHA points/qualifications are not earned with these classes.

**Registry Requirements** A copy of the registration certificate showing proof of ownership must be submitted with the entry form at the time of making entry. In case of a lessee, pending transfer, contract of sale, or cash sale, a copy of the registration certificate must be submitted, along with proof of lease or ownership and these documents must be attached to the copy of the registration certificate and must contain the correct registered name and number of the horse, date, and the signature of the seller or lessee.

**Show Rules** All classes will be conducted in accordance with the rules of AHA and WDAA. Judging, class specifications, rules and conduct shall be in accordance with the current USEF/EC Rulebook. All decisions made by the Judge and/or Show Management are final and cannot be protested. Show Management reserves the right to ask any exhibitor to leave the show grounds for any reason including but not limited to: unsportsmanlike conduct and animal cruelty.

**Recognition** Entries shall receive all appropriate qualifications and points for Regional, Nationals and AHA Achievement Awards in applicable classes. If you require verification of qualifications contact the Show Secretary to complete paperwork before leaving the show.

**Refusal of Entries** The Show Management reserves the right to refuse, accept conditionally or to cancel any entries of any exhibitor.

**Refunds** In case of injury or illness of horse or rider before the event, a vet certificate or medical excuse is required before 8 am of the first day of the event. All fees except the office fee will be refunded. Refunds will be mailed within 30 days.

**AHA MEMBERSHIP STATEMENT:**

EACH COMPETITOR (THIS INCLUDES AT LEAST ONE RECORDED OWNER AND ALL TRAINERS, DRIVERS, RIDERS, HALTER HANDLERS, COACHES AND THE PERSON(S) SIGNING THE ENTRY BLANK) IN AN ARABIAN HORSE ASSOCIATION RECOGNIZED ARABIAN DIVISION, AT THE TIME OF ENTRY INTO A COMPETITION, MUST SUBMIT A COPY OF A VALID AHA MEMBERSHIP/COMPETITION CARD, JOIN AHA OR PAY AN AHA SINGLE EVENT MEMBERSHIP FEE PER COMPETITOR. WHEN AN AGENT SIGNS FOR THE OWNER AT AN AHA RECOGNIZED COMPETITION, BOTH THE OWNER AND AGENT MUST BE MEMBERS OF AHA OR PAY THE AHA SINGLE EVENT MEMBERSHIP. SINGLE EVENT MEMBERSHIP IS NOT ACCEPTABLE AT AHA REGIONAL OR NATIONAL COMPETITIONS. EXHIBITORS IN WALK-TROT 10 & UNDER CLASSES ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS AT QUALIFYING COMPETITIONS, BUT MUST HAVE AN AHA MEMBERSHIP WITH COMPETITION CARD AT AHA REGIONAL AND NATIONAL COMPETITIONS. EXHIBITORS IN LEAD LINE CLASSES OR PARENTS/GUARDIANS SIGNING FOR MINORS ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS. (BOD 5/12)

**AHA ENTRY AGREEMENT – Regional and Local Ride**

I have read the rules concerning competitions as printed in the Arabian Horse Association® (AHA®) Handbook and Directory and agree to be bound by and subject to those Rules.

**AHA ASSUMPTION OF RISK, RELEASE AND INDEMNIFICATION**

**This document waives very important legal rights. Read it carefully before signing.**

In consideration for AHA permitting me to participate in this Competition, and by signing the entry blank, I agree as follows:

I AGREE that I choose to participate voluntarily in this Competition, as a rider, driver, handler, lessee, owner, agent, coach, trainer, junior exhibitor, or as a parent or guardian of a junior exhibitor. I AM FULLY AWARE AND ACKNOWLEDGE THAT HORSE SPORTS AND PARTICIPATION IN THIS COMPETITION INVOLVE SERIOUS RISK OF HARM INCLUDING, BUT NOT LIMITED TO, RISKS OF ACCIDENT, SERIOUS BODILY INJURY, INCLUDING DEATH, BROKEN BONES, HEAD INJURIES, TRAUMA, PAIN, AND SUFFERING, AND PROPERTY DAMAGE. I ASSUME ALL RISKS OF HARM TO ME, MY HORSE OR MY PROPERTY.

I AGREE for myself, my heirs, executors, administrators, successors and assigns to release AHA, the Competition, the facilities leased by the Competition and the owner(s) of the facilities, and all of their respective officers, officials, directors, employees, agents, personnel, volunteers, affiliated organizations and insurers (collectively, the "Released Parties") from any and all claims for damage, loss, or injury to myself, other persons, horses or other property belonging to me to the fullest extent permitted by law that arises out of or relates in any way to the Competition and my participation in the Competition INCLUDING, BUT NOT LIMITED TO, DAMAGES, LOSS, OR INJURY RESULTING FROM ANY ACTS, FAILURE TO ACT, NEGLIGENCE OR NEGLECT OF OTHER ENTRANTS, THE RELEASED PARTIES, THEIR CONTRACTORS OR INVITEES, as well as for theft, vandalism, fire, other casualty damage, or damage arising out of any defects in the premises.

I AGREE to indemnify and hold harmless (that is pay all losses, damages, attorneys fees and costs of) the Released Parties from and against any and all claims, demands, penalties, actions, losses, costs, damages, injuries, liabilities and obligations (including attorneys fees) of whatsoever kind and nature, which may be asserted against or incurred by any of them as a result of (1) my participation in the Competition or (2) any act, failure to act, or neglect (a) by me, my agents, employees, riders, handlers, trainers, coaches, drivers, contractors or invitees, or (b) by any animal owned or exhibited by me or in my custody or control.

I AGREE and represent that I am qualified and eligible to enter and/or participate in the Competition, and every horse I am entering is qualified and eligible as entered.

I AGREE to accept AS FINAL any decision of AHA, the Ride Management Committee or Ride Officials concerning my qualification or the qualification of my horse to enter the Competition or any results of the Competition, except to the extent that the Rules of AHA or the Competition permit a protest or hearing of such decisions. Should a hearing be requested, I agree to accept AS FINAL the decision of the particular hearing body. I agree to release, hold harmless and not to sue AHA, the Competition Sponsor, their officers, directors, employees, volunteers or members concerning any decision of AHA, the Competition, its Ride Management Committee, Ride Officials or any hearing body that relates to my qualifications or my horse(s)' qualifications to enter the Competition or any results of the Competition.

I AGREE that AHA has the sole right to control, sell, supervise or give away (or assign to others the right to do so) the exclusive rights to broadcast, televise, reproduce, transmit and disseminate all or part of this event, and I agree that AHA may use or assign, in any way AHA sees fit, photographs, films, videos, audios, cablecasts, or other likenesses of me and my horse taken during the course of the Competition for the promotion, coverage or benefit of the Competition or AHA. Those likenesses shall not be used to advertise a product and they may not be used in such a way which implies endorsement of any company, product, product category or service. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation.

By signing below as a parent or guardian of a junior exhibitor, I consent to the child's participation and agree to all of the above provisions, and further agree to assume all of the obligations of this AHA Assumption of Risk, Release and Indemnification personally and on behalf of the child.

This AHA Assumption of Risk, Release and Indemnification is governed by the Laws of the State of Colorado and is intended to be interpreted as broadly as possible. I agree that exclusive jurisdiction and venue (place) for any legal action against AHA, its officers, directors, employees, volunteers or agents shall be in the local district courts or the federal court of the State of Colorado. If any part of this agreement is determined to be unenforceable, all other parts shall remain effect.
