## INFORMATION & RULES

**Add/Scratches** Additional classes may be added without penalty except dressage and western dressage. Entries must be made prior to the close of the preceding session. Even exchanges for post entries and scratches will be allowed provided they are done at the same time. **Entry fees will not be returned for scratched classes.**

**Awards** Regular classes—six ribbons. Championship classes—six ribbons and trophies.

**Breeding In Hand Classes** will use the in-ring procedure with comparative judging.

**Calls for Classes/Tack Holds** The PA system is to be considered a courtesy only. Tack holds will be honored for back to back classes only. The office must be notified before the session begins.

**Entries** must be postmarked by JUNE 2, 2026. All entries postmarked after June 2 will be considered post entries and an additional fee of \$25 per horse will be charged. An entry is considered complete if legible AHA registration number, USEF horse ID number, AHA membership numbers, USEF membership numbers, USDF membership numbers, and WDAA membership numbers for every owner, exhibitor, coach, and trainer, if applicable is included. ALL SIGNATURES AND COMPLETE FEES ARE REQUIRED FOR EVERY ENTRY. If any piece of information is missing, the \$10 incomplete entry fee will be charged.

**Bedding** Shavings are available on the grounds. Pre-orders are encouraged and can be ordered on the entry blank. Extras can be ordered in the show office. **Hay and grain are not available on the grounds. Straw is prohibited.**

**Horse Health Requirements** All horses must present a current negative Coggins dated within 12 months of the show and proof of flu/rhino vaccination dated within 6 months of the show. **Out of state horses need a CVI dated within 30 days of the show. In state horses need a CVI dated within 6 months of the show.**

**EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.”**

**LIABILITY:** You assume the risk of equine activities pursuant to Pennsylvania Law.

**INDEMNITY AND RESPONSIBILITY** All entries are accepted with the understanding that neither PAHA, the Centre County Grange Fair- grounds, the Show, the Show Committee, nor any Show Official will be held responsible for any loss, damage, or injury to any horse exhibited or any article of any kind. All horses shall be under the control and direction of the Show Committee but solely at the risk of the exhibitor, who will be responsible for any loss, damage or injury to any person, animal or property occasioned by him, and the exhibitor shall indemnify the above mentioned parties against any and all loss, damages and liability thus occasioned, including, but not limited to, any and all legal costs, including attorney fees, which may be incurred as a result thereof. Submitting of any entry form to the Show shall constitute an acceptance by each person signing same of the provisions herein set forth.

**MOTORIZED VEHICLE STATEMENT** Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

**AHA NON-MEMBER FEE** AHA requires every owner, trainer, rider, driver, handler or coach who does not possess a *current COMPETITION membership card* pay a \$35 Single Event Membership Fee per person per show. Those showing in only the walk-trot classes and those only showing in the opportunity classes are exempt from all membership fees.

**OPPORTUNITY, EXHIBITION, & ACADEMY CLASSES** are open to all horses. If a horse/rider is **ONLY** entered in opportunity or academy classes, they are exempt from AHA and USEF membership and/or horse fees. Points/qualifications are not earned with these classes.

**POST ENTRIES** will be accepted for all classes except dressage and western dressage. A \$25 fee will be charged per horse for entries not received by the entry deadline. There are no class post entry fees. For our convenience, you may start a show account by leaving a signed, blank check with the secretary.

**REGISTRY REQUIREMENTS** Ownership will be determined by the name listed on the current registration papers. In case of a lessee, pending transfer, contract of sale, or cash sale, a copy of the registration certificate must be submitted, along with proof of lease or ownership and these documents must be attached to the copy of the registration certificate and must contain the correct registered name and number of the horse, date, and the signature of the seller or lessee.

**REFUNDS** In case of injury or illness of horse or rider before the event, a vet certificate or medical excuse is required before 8 am of the first day of the event. Scratches during the show require a vet certificate. Entry fees will be refunded. In cases of a complete event scratch of horse or rider, all fees except the office fee will be refunded. Refunds will be mailed within 30 days.

**RINGS & FOOTING** Indoor Arena 50' X 300' – sand mix. Outside rings 140' X 230' – sand & screenings. Covered arena -140' X 230' – sand & screenings.

SHAVINGS will be available on the show grounds. We encourage you to pre-order shavings on your entry blank. Extras can be purchased in the show office.

STALLIONS are prohibited in all lead line, walk-trot 10 & under classes, and academy classes.

STABLING will not be reserved unless pre-paid. Stalls are available beginning 8am on Thursday, June 18th and must be vacated by Sunday 6pm. Stalls are permanent with doors. Anyone using an unassigned stall will be charged a stall fee plus \$25. Stall assignments are final unless changed by the stable manager. Microwaves, refrigerators, crockpots, commercial grade fans and air conditioners are not permitted in the barns. DO NOT SHOW UP WITHOUT CALLING FOR STALLS FIRST.

WALK/TROT 10 & UNDER The rider must never have been judged in a class at a licensed competition that requires a canter or lope. Exception: short stirrup reining and walk-trot cross rails.

WALK/TROT 11 & OVER Open to amateur & junior riders. Eligibility to show in these walk/trot classes begins with each show season. Once a rider shows in a class requiring a canter or lope, the rider becomes ineligible to show Walk/Trot for the remainder of the show season. Exception: cross rails and short stirrup reining.

**AHA MEMBERSHIP STATEMENT: EACH COMPETITOR (THIS INCLUDES AT LEAST ONE RECORDED OWNER AND ALL TRAINERS, RIDERS, DRIVERS, HALTER HANDLERS, COACHES AND THE PERSON(S) SIGNING THE ENTRY BLANK) IN AN ARABIAN HORSE ASSOCIATION RECOGNIZED ARABIAN DIVISION, AT THE TIME OF ENTRY INTO A COMPETITION, MUST SUBMIT A COPY OF A VALID AHA MEMBERSHIP/COMPETITION CARD, JOIN AHA OR PAY AN AHA SINGLE EVENT MEMBERSHIP FEE PER COMPETITOR. WHEN AN AGENT SIGNS FOR THE OWNER AT AN AHA RECOGNIZED COMPETITION BOTH THE OWNER AND AGENT MUST BE MEMBERS OF AHA OR PAY THE AHA SINGLE EVENT MEMBERSHIP. SINGLE EVENT MEMBERSHIP IS NOT ACCEPTABLE AT AHA REGIONAL OR NATIONAL COMPETITIONS. EXHIBITORS IN WALK-TROT CLASSES ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS AT QUALIFYING COMPETITIONS, BUT MUST HAVE AN AHA MEMBERSHIP WITH COMPETITION CARD AT AHA REGIONAL OR NATIONAL COMPETITIONS. EXHIBITORS IN LEAD LINE CLASSES OR PARENTS/GUARDIANS SIGNING FOR MINORS ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS. (BOD 5/12)**

**Directions to the Grounds:**

**GPS ADDRESS: 169 Homan Lane, Centre Hall PA 16828**

**From the West: US 322E/I99 around State College. Exit 45E turn left - go 6 miles; entrance on left, but watch for Grange Fairgrounds sign on right. If you get to the light at the intersection with the Sheetz, you've gone too far.**

**From the East: US 322W to Potters Mills; turn right onto PA 144 to Old Fort; turn left on Rt 45 (Sheetz is on your right), go 1/2 mi, entrance on right but watch for Grange Fairgrounds sign on left.**

**From the East via Rt 80: Exit at Bellefonte; follow Rt 220/I99 to US 322E Exit at Rt 45E - turn left for 6 miles; entrance on left but watch for Grange Fairgrounds sign on right. If you get to the light at the intersection with the Sheetz, you've gone too far.**

**NOT RECOMMENDED: Hauling a trailer up the mountain on Rt 144 from Pleasant Gap through Centre Hall – it is curvy and steep!**

*Diesel fuel is available at the Sheetz, however, it is tight. Fuel up before you arrive.*

# ACADEMY RIDING PROGRAM

*WHERE CONFIDENCE BEGINS AND COMMUNITY GROWS*

## **Where Confidence Begins and Community Grows.**

The AHA Academy Riding division is designed to welcome new riders into the Arabian horse show world by offering a positive, low-pressure introduction to competition. Open to beginning riders of any breed, Academy classes provide an opportunity to build skills, gain confidence, and experience the joy of showing within a supportive and educational environment.

Through beginner-focused classes offered at Arabian horse shows, the Academy division helps riders, instructors, and shows grow our community together - laying the foundation for lifelong involvement with the Arabian horse.

### **RIDERS**

- \* Are encouraged to be in a professionally operated lesson program. (not required)
- \* Are encouraged but not required to be an AHA member. First Year Academy Exhibitors are eligible for a FREE AHA Youth Membership.
- \* Riding saddle seat suits, hunt coats and western chaps are NOT allowed
- \* Riding pants, jodhpurs, breeches or colored jeans are considered appropriate.
- \* A neatly fitted shirt or top is suggested.
- \* A riding helmet is MANDATORY for riders 18 years of age and under and suggested for all ages.
- \* Appropriate footwear with a small heel is MANDATORY.
- \* Riders are NOT allowed to cross enter into any non-Academy riding classes and are ineligible to compete in Academy classes once they have shown in a full riding suit or in a non-Academy type show.

### **HORSES & EQUIPMENT**

- \* Horses must be regularly used as lesson horses: While it is preferred that horses are owned by instructors, horses may be owned or leased by riders IF they are used and shown regularly by other riders as a lesson/school horse.
- \* Any breed of horse is allowed, and registration is not required. Horses must be suitable to Academy division displaying good manners and a quiet disposition.
- \* Any horse and rider that is deemed unsafe or is not abiding by these rules may be eliminated by the horse show management or judge.
- \* A cut-back saddle for saddle seat, western saddle for stock seat, and hunt saddle for hunt seat are to be used.

- \* Work bridles and bits, including snaffles are allowed, and running martingales are permitted and encouraged. However, the tie down martingales is NOT allowed.
- \* Horses can cross enter in any Academy type class within the same show, but riders may not cross enter between the Leadline, Walk/Trot, or the Walk/Trot/Canter classes.
- \* Show grooming is permitted, but not necessary as HORSES ARE NOT TO BE JUDGED.

## **JUDGING**

- \* All Academy classes are to be judged on the ability of the rider to control and show their horse to its best advantage. and upon the riding skills of the rider.
- \* Each class should be judged on the rider's basic equitation and horsemanship skills suited to the class discipline, with emphasis placed on the rider's ability to control the horse at all times, identify correct diagonals and leads promptly, and to control their horses rate in a consistent manner.
- \* Riders should convey the impression of good posture, balance, and effective control while commanding proper speed of gaits and show ring placement.
- \* Headers are allowed in the line up in all walk/trot classes.
- \* HORSES ARE NOT TO BE JUDGED, only the rider's ability to control themselves and their horses while presenting themselves to their advantage.
- \* Horsemanship Pleasure is meant to differ from the Equitation class in that it is judged more on the rider's ability to display their horse to its best advantage, communicating to the judge through their horsemanship and riding abilities that the horse is a pleasure to ride and can be guided and set up to show to its best advantage.
- \* Classes may be split at the discretion of show management.
- \* Entries into these classes must follow written Show Premium rules but are NOT AHA or USEF sanctioned classes.



**Membership Requirements for USEF-licensed/USDF-recognized Competitions:** Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

**Exceptions:**

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

**Memberships Defined**

**Participating Membership (PM):** A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$100), 5-years (\$400), or life (\$2,000). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21<sup>st</sup> birthday by December 1 of the current membership year (\$80). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan<sup>®</sup>/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

**Group Membership (GM):** A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program.

**Business Membership (BM):** A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$280) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

**Non-Member (NM) Identification Number:** For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$55 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

**Horse Identification (HID) Number:** A one-time tracking number for horses (\$45). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan<sup>®</sup>/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$95. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

**Lifetime Horse Registration (LHR):** A horse with an LHR (\$140) is eligible for Adequan<sup>®</sup>/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

**How to Join USDF**

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.
